A meeting of the Regatta Committee of the Barneгат Bay Yacht Racing Association was called to order by Vice Commodore Patricia Applegate at 0830.

Roll call, by Secretary Betty Jane France, indicated that twelve of the thirteen member clubs were represented; Pine Beach Yacht Club was not.

### ***TRYC Team - Sears Cup Semifinals***

Vice Commodore Applegate received a letter from Britton Tullo, Toms River Yacht Club, requesting permission to enter a team representing the BBYRA in the Sears Cup Semi-final competition in Annapolis, Maryland. The team would be comprised of Skipper Britton Tullo, Crew Jessica Stewart, and Crew Donovan Marvin.

A motion was made, seconded, and passed, with 12 affirmative roll call votes, to approve the request.

### ***Trophies***

Trophies were discussed. Wood plaques have been presented for three or four consecutive years. We will continue getting trophies through Dick Thomas and will explore using plaques, silver, glass, acrylic, etc.

### ***Safety on the Bay***

P/C Roger Brown explained that International Order of Blue Gavel is working to improve safety on the bay.

1. Two hundred whistles were donated for distribution and are now part of the required safety equipment.
2. Roger received a donation of ten first aid kits from an individual and Johnson & Johnson which are part of the equipment on patrol boats.
3. Roger obtained a donation of \$5000 from a "friend of the bay" to purchase a defibrillator, a case, and an oxygen tank.

Governor Whitman signed a law into effect that volunteers, if certified, are not held liable unless gross negligence is evident. A defibrillator can't kill; it can only save a life. Obsolescence was questioned. It was felt that a maintenance number should be included in the BBYRA budget.

The meeting was adjourned at 0855.

### **1. Scoring Program**

The current program does not score DNCs correctly.  
Scorer Harold Lewry proposes that DNCs be scored as CUTs.  
Peter Chance is working on the program.  
"Zero, zero" means no score.

The three worst scores of each boat will be dropped.  
A decision was made that no changes in the scoring be made at the present time; if the program cannot be changed, this problem will be revisited.

### **2. Reingold Song**

At the October 2, 1999 Executive and Delegates Meetings, a letter from Bill Warner was read and acted upon.

P/C Don McNeil will talk to BHYC Commodore Zoe Wells to see if the situation was addressed by her club.

The wording of the motion may have to be expanded.
